#### **FOREWORD**

The prime objective of the establishment of Civil Aviation Authority of Nepal (CAAN) is to make the operations of national and international flights, air communication, air navigation and air transportation services safe, regular, efficient and standard. Safety is the fundamental and foremost prioritized domain of aviation because there are lives involved in every operation of aircraft. This Airport has been inaugurated on 1st January, 2023. It is located at Pokhara, the most popular tourist destination of the County which is situated 200 Km far west from the Capital city, Kathmandu. This Airport serves as main gateway for the pilgrims and the tourists to travel the famous religious place including Muktinath, Jomsom and Annapurna Round trek. Safety has been a prime concern since very beginning of the establishment of this airport. This Aerodrome Safety Report, 2023 is the first edition of the Aerodrome Safety Report. It provides a summary on safety activities, initiatives and safety performance indicators, safety promotional activities. Information contained in this report is based on aerodrome safety data (mandatory and voluntary) collected by PIA Aerodrome Safety Office through safety reporting process from within safety reporting system as well as from aircraft operators and other stake holders in PIACAO. It is also an attempt to depict whereabouts of PIACAO's SMS Implementation phase. I hope this report will successfully serve the purpose of its publication and play an important part in inculcating safety culture in the aviation stakeholders of Nepal.

#### **EXECUTIVE SUMMARY**

Pokhara International Airport Civil Aviation Office (PIACAO) is located at mountainous region at an altitude of 803.38m above the mean sea level in Pokhara city of Nepal. There are currently 4 airlines operating domestic flights to and from PIACAO in first three months of 2023 with total 3298 Flight Movements. Every result and trend presented in this report should be understood from the vantage point of aforementioned facts and data. Regarding Hazard and Occurrence Reporting, it is one of the prime sources of safety information. The Aerodrome Safety office is focusing on activities like aerodrome safety awareness, hazard identification, risk management programme, foreign object debris cleaning/removing campaign etc.

Occurrence Reporting is one of the sources of reactive safety information. 421 occurrences were reported in first three months since the opening of this Airport. On the basis of this reporting, PIACAO has identified certain categories of occurrences. The safety performance indicators and targets for the year 2023 have been set on the basis of those categories of occurrences. Analyzing the type of hazard and occurrences based on number and severity of the occurrences, it has been revealed that three areas seem to posing risk to aerodrome significantly for the first three months of 2023; namely Wildlife Activities, Wildlife Strikes and occurrences related to Aerodrome.

This report also categorizes types of incident and accident occurred in PIACAO along with aircraft type involved. An attempt has been made to portray patterns of each safety performance indicators based on available data. There are 6 lagging safety performance indicators identified, and 2 leading safety performance indicators targeted for the year 2023.

#### **AIRLINES IN OPERATIONS**

As of date of publication of this report, total 4 Airline operators are operating as domestic operations in PIACAO. Below is the list of Airline Company currently operating in PIACAO.



#### AIR TRAFFIC MOVEMENT

#### **Domestic**

In this category, total air traffic movement segregated at PIACAO in first 3 months in the year 2023 is 3298. As the chart below indicates March is the month having highest air traffic movement; and February is the month having lowest air traffic movement; and the average air traffic movement for 3 month is 1099.





#### AIRCRAFT INCIDENT/ACCIDENT


#### SAFETY PERFORMANCE INDICATORS


PlACAO has identified safety performance indicators that are characterized as lagging and leading indicators. Considering the nature of occurrences reported in the last 3 months, PIACAO has identified categories of hazards and occurrences. Safety Performance Indicators listed in this report are based on these reports. PIACAO has collected 421 hazards and occurrences as indicated in the incident report. PIA Aerodrome Safety Office is receiving hazards and occurrence information through Internal reporting system as well as from aircraft operators and other stakeholders of PIACAO. Internal reporting is received from different wings of the airport including Airside Management Section, Electro-mechanical Section, Civil Engineering Section, Rescue and Fire-fighting Section. These divisions and units report occurrences within their area of responsibility.



#### **OCCURRENCE REPORTING**


As stated earlier, total number of occurrences reported in first 3 months of 2023 are 421. They are categorized into 6 groups as suggested by ICAO. PIACAO has categorized those occurrences as lagging indicators. Thus including leading indicators in total we found 8 categories of Safety Performance Indicators.





#### Aerodrome (ADRM)


PIACAO has collected log of Foreign Object Debris (FOD) on Movement Area. FODs are also considered to be serious threat to aircrafts, hence treated as hazards. PIACAO has also collected records of airfield lighting fault. These data related to FOD and airfield lighting faults area has been presented in the following chart. The chart below indicates that the month of January has highest number of occurrences and March has the lowest number of occurrences.





#### Wildlife Activities (WILD)


PIACAO has collected log of wildlife activities (wild animals and birds) observed at movement area; approach, landing and take- off Path. These wildlife activities are recorded and reported to Aerodrome Safety Office. The data related to wildlife activities are presented in the chart below. This chart indicates that the month of January has the highest number of wildlife activities and March having lowest number of Wildlife activities in PIACAO.





#### Bird Strikes (BIRD)


PIACAO has collected the log of bird Strike which were stroke at aircraft movement area; approach, landing and take-off paths. Such Wildlife Strike is considered to be serious Hazards. The data related to bird strikes have been presented in the following chart.






#### Runway Incursion (RI)

Runway incursion includes entry of people, equipment or aircraft in active area without permission from Air Traffic Control Tower. In the first three month of 2023, there have been no runway incursion incidents at PIACAO which is indicated in the chart below.



#### Fuel Related (FUEL)


Fuel spillage if not controlled in time, it creates quite serious consequences at airports. Fuel spillage may be spillage of hydraulic oil or oil spillage from ground support equipment and/or from an aircraft on the movement area. In the first three month of 2023, there have been no fuel related incidents at PIACAO which is indicated in the chart below.





#### Others (OTHR)

PIACAO has also collected the records of missed approach that was carried out in the first three months of 2023. Missed approach of aircraft was carried out mainly due to wildlife activities. Missed approach is considered to be a corrective measures of consequences. The data related to missed approach have been presented in the following chart.



#### Safety Meetings

PIACAO Aerodrome Safety Manual has prescribed different kinds and levels of Safety Committees and their meetings such as Safety Review Board, Safety Action Group, Runway Safety Team, etc. Hence for Aerodrome safety purpose, PIACAO has been conducting safety related meetings in the first three months of 2023 and have been presented in the following chart.
