Bidders, submitting their bid electronically, should deposit the cost of bidding document of NRs. 3,390/- (Three Thousand Three Hundreds Ninety Rupees only) [nonrefundable] in the following account of PIACAO as specified below.

5. Electronic bids must be submitted to the office **Pokhara International Airport Civil Aviation Office, Pokhara, Kaski** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 pm on 2082/06/07** on Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00pm dated 2082/06/07** at the office of **Pokhara International Airport Civil Aviation Office, Pokhara, Kaski**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **65,000.00 /- (NRs. Sixty five Thousand Rupees only)**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and bid security** shall remain the same as specified for the original last date of bid submission.
